

THIS INDENTURE, Made this 23rd day of April in the year of our Lord one thousand nine hundred and sixty-eight between

CITY OF JAMESTOWN, a municipal corporation,

whose postoffice address is Jamestown, North Dakota, (a corporation under the laws of the State of North Dakota), party of the first part, and

JAMESTOWN MUNICIPAL AIRPORT AUTHORITY, a municipal authority created under Section 2-06-02 of the North Dakota Century Code of the State of North Dakota, whose postoffice address is Jamestown, North Dakota, of the County of Stutsman and State of North Dakota, part Y of the second part,

WITNESSETH, That the said party of the first part, in consideration of the sum of One Dollar and other valuable consideration to it in hand paid by said party of the second part, the receipt whereof is hereby acknowledged, does by these presents, GRANT, BARGAIN, SELL and CONVEY unto the said party of the second part, its successors and assigns, FOREVER, all that that tract or parcel of land and real estate lying and being in the County of Stutsman and State of North Dakota, described as follows, to-wit:

Southwest Quarter (SW 1/4) of Section Seventeen (17); South Half (S 1/2) of Section Eighteen (18); All of Section Nineteen (19); and West Half (W 1/2) of Section Twenty (20); all located in Township One Hundred Forty (140), Range Sixty-three (63), Stutsman County, North Dakota.

TO HAVE AND TO HOLD THE SAME, Together with all the hereditaments and appurtenances thereunto belonging or in anywise appertaining to the said party of the second part, its successors and assigns, FOREVER. And the said CITY OF JAMESTOWN, a municipal corporation, party of the first part, for itself and its successors, does covenant with the said party of the second part, its successors and assigns, that it is well seized in fee of the land and premises aforesaid, and has good right to sell and convey the same in manner and form aforesaid; and that the same are free from all incumbrances

and the above bargained and granted lands and premises, in the quiet and peaceable possession of the said party of the second part, its successors and assigns, against all persons lawfully claiming or to claim the whole or any part thereof, and said party of the first part will WARRANT AND DEFEND.

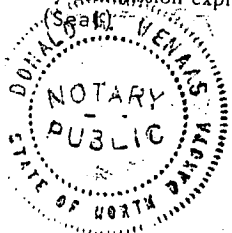
